Tuition & the annual registration fee of \$27.00 is due at the time of registration. Tuition is due on the 1st of each month and no later than the 8th. Payments made after the 8th will incur a \$15.00 late charge. You can pay your account online or set up CC auto pay, mail it to the main office (PH), or bring it into the studio. We have a tuition drop box in both locations for your convenience. Tuition is charged the same price monthly September-May regardless of unattended classes or holiday breaks. Tuition and deposit fees are non-refundable. All accounts need to be paid in full by Annual Spring Recital. We do not prorate months for missed days, holidays or school vacations. I hereby assume all financial responsibility for above student(s) enrolled at Pat Harris School of Dance, Broadway Dance & Event Center. I further understand that I will be charged for all classes until I have given 30 days' notice to the school making them aware of my or my child's withdrawal from classes. There is a \$25.00 returned check charge.
